**ORDINANCE 16-2494 – AN ORDINANCE AMENDING CHAPTER 17, ARTICLE 30 OF THE CODE OF THE BOROUGH OF BERGENFIELD, ENTITLED “DEPARTMENTS”**

was introduced at a work session meeting of the Mayor and Council of the Borough of Bergenfield, in the County of Bergen, New Jersey, held on Tuesday, May 17, 2016, and will be further considered for final passage after public hearing at a Work Session meeting of the Mayor and Council to be held in the Executive Chambers, Bergenfield Municipal Center, 198 North Washington Avenue, Bergenfield, New Jersey on Thursday, June 9, 2016 at 8:00 p.m. prevailing time, or as soon thereafter as the matter can be heard.

A clear and concise statement of this ordinance is to amend Chapter 17, Article 30 of the Code of the Borough of Bergenfield, entitled “Departments,” to amend the title of Tree Climber in the Department of Public Works to “Tree Maintenance Worker 2,” in accordance with Civil Service rules.

**Ordinance No. 16-2494**

**AN ORDINANCE AMENDING CHAPTER 17, ARTICLE 30 OF THE CODE OF THE BOROUGH OF BERGENFIELD, ENTITLED "DEPARTMENTS"**

**WHEREAS**, Chapter 17 of the Code of the Borough of Bergenfield sets forth all regulations regarding the Department of Public Works within the Borough of Bergenfield; and,

**WHEREAS**, on February 16, 2016, the Borough adopted Ordinance No. 16-2485 establishing the position of Tree Climber in the Department of Public Works; and

**WHEREAS**, in accordance with Civil Service Rules, this title must be amended to "Tree Maintenance Worker 2".

**BE IT ORDAINED**, by the Mayor and Council of the Borough of Bergenfield, County of Bergen and State of New Jersey that the title of Tree Climber in the Department of Public Works is hereby amended to Tree Maintenance Worker 2; and

**BE IT FURTHER ORDAINED** by the Mayor and Council of the Borough of Bergenfield that all other portions of the Ordinance shall remain unchanged.

Severability All provisions of this Ordinance are severable. If for any reason, any provision of this Ordinance is held to be invalid, the validity of the remainder of the Ordinance shall not be affected.

Effective Date. This Ordinance shall become effective upon final approval and publication, pursuant to law, and upon completion of all outstanding cases.
